


# Why use court records?

- Puts your ancestor at a certain place and a certain time
- Provides information about family connections and relations not found in other records (ex. may explain paternity or even disappearance of ancestor)
- Overlooked source in early published genealogies
- Adds to the life story of your ancestor



That from and after the passing this act, Moses Porter Phelps, resident in Boston, in the county of Suffolk, son of Charles Phelps, of Hadley, in the county of Hampshire, be and he hereby is authorized and allowed to take, use and bear the name of Charles Porter Phelps, instead of the name of Moses Porter Phelps, and by that name, to be forever hereafter known and called in all processes and records whatsoever. [February 15, 1796.

AN ACT to change the Name of Ephraim Farrar, to the Name of John Farrar.

*Be it enacted, etc., as follows:*

That from and after the passing of this act, Ephraim Farrar, of Worcester, in the county of Worcester, son of John Farrar, late of Shrewsbury, in the county of Worcester, deceased, be, and he hereby is authorized and allowed to take, use, and bear the name of John Farrar, and by that name to be forever hereafter known and called, in all precepts and records whatsoever. Amory, and shall be called and known by that name at all times hereafter. [June 14, 1796.

AN ACT to alter the Name of Samuel Hewes.

*Be it enacted, etc., as follows:*

That from the passing of this act, Samuel Hewes, of Boston, in the county of Suffolk, merchant, son of Samuel Hewes, late of said Boston, deceased, be, and he hereby is authorized to take and use the name of Samuel Hill Hewes, and that he be called and known by that name at all times hereafter. [November 24, 1796.

This database includes all the names changed by the Maine Legislature between 1820 and 1891. After 1876, Maine's probate courts were authorized to change names, and the Legislature performed this task far less frequently.

Richard P. Roberts compiled a more extensive list of Maine name changes—including those granted Maine residents by the Massachusetts Legislature and probate courts—which was published as "Name Changes of Maine Residents, 1803-1892" in *The Maine Genealogist* between Nov. 1995 and Feb. 2001 (vols. 17-23). See also Linda R. Aaskov's "Official Name Changes in Maine to 1820" in the *York County Genealogical Society Journal* of April 1986 (vol. 1).



# Adoption Records

# Adoptions Before 1851


- Akin to the fostering system. Parents retained the legal rights over their children if a guardianship was established.
- Children could be "bound out" as indentured servants until adulthood
- Relatives often adopted extended family members
  - Single mother stigma
  - Widowed parents
  - Financial difficulties

# Adoption of Children Act (1851)

- First modern adoption law – passed in Massachusetts and copied in other states
- Passed to ensure adoptions were "fit and proper"
- The legal rights of the biological parents is terminated
- Adopted children were given right to inherit from their adoptive parents
- Children aged 14 and over cannot be adopted without their consent

# Orphan Trains

- Between 1854 and 1929, the New York Children's Aid Society transported 250,000 children from New York, Boston and other Eastern cities out by train to the Midwest and western states
- Families showed up to train stations to "look over" the children

## Divorce Index

When the State began to maintain vital statistics in 1892, they also collected information on divorces in the State. The clerks of each court were required to submit lists of divorces each year. The volumes in this collection are the compilations of these records from 1892 to 1963. Each volume generally covers a two year period (with a couple of exceptions), and each year is then arranged by county alphabetically. Within the counties are the lists of all divorces, sometimes including maiden name of the wife, date of marriage, date of divorce, and cause of divorce. However, not all clerks filled in all the information, so many pages will just include the names of the two parties.

This information can then be used to locate the file in the court records or order an abstract from the [Office of Data, Research, and Vital Statistics](#). Divorces taking place in 1930 or later need to be requested directly from the court. A list of Superior Courts and their contact information can be found [here](#) Divorces prior to 1930 can be found on microfilm at the Maine State Archives, or, in many cases, online at FamilySearch by searching for the county in the [Card Catalog](#) and then selecting court records in the search results.

These volumes have not been indexed, but for an index of divorces in Maine prior to 1892, which includes the divorces in these records up to 1903, see [MaineGenealogy.net](#). 

RESPECTFULLY represents Daniel Rooney of Boston in said District Massachusetts an alien, and a free white person, that he was born in Langford Ireland

on or about the seventeenth day of March in the year of our Lord eighteen hundred and forty seven and is now about thirteen years of age; that he arrived at East Boston District of Mass.

Twenty Second in the United States of America, on or about the day of April in the year of our Lord eighteen hundred and Sixty four being then a minor under the age of eighteen years; that it then was and still is, his bona fide intention to reside in and become a citizen of the United States of America, and to renounce all allegiance and fidelity to every foreign Prince, State, Potentate, and Sovereignty whatsoever—more especially to Victoria, Queen of the United Kingdom of Great Britain and Ireland,

whose subject he has heretofore been: All which appears in the Record of the Honorable Court,

to wit, on the day of A. D. 18

And the said petitioner further represents, that he has ever since continued to reside within the jurisdiction of said United States, that he has never borne any hereditary title, or been of any of the orders of nobility; that he is ready to renounce and abjure all allegiance and fidelity to every foreign Prince, Potentate, State, or Sovereignty whatever, and particularly to Victoria, Queen as aforesaid,

whose subject he has heretofore been; that he is attached to the principles of the Constitution of the United States of America, and well disposed towards the good order and happiness of the same.

And the said petitioner further represents that he enlisted in the Volunteer forces of the Armies of the United States, and that he was honorably discharged therefrom on the day of A. D. 18

Wherefore your petitioner prays, that he may be admitted to become a citizen of the said United States of America, according to the forms of the statute in such case made and provided

Deft. confessed and was ordered to pay £7.9s.4d. to Capt. 
