



- More than names and dates - stories and how our families fit into history
- Stems from ancient Greek
 - *Genea* meaning generation
 - *Logia* meaning telling or discourse or study of



Step 1

- Identify what you know

Step 2

- Decide what you want to learn (Research goal)

Step 3

- Identify and locate your sources


Step 4

- Research!

Step 5

- Analyze

Step 1: Identify What You Know

- Interview yourself
- Talk to relatives—What do they know? What family stories were they told?
- Record data using a family group sheet, chart, or genealogical software

Example: Family Interview Questions

- Where did you live when you were growing up?
- How did your family come to live there?
- Were there other family members in the area? What were their names?
- What was your family religion?
- What family stories have you heard about your parents? Your grandparents? More distant relatives?
- What stories have you heard about the European (or other) origins of your family members and their immigration to America?

- What kinds of family traditions did you hear?


Family Group Sheet



Toolkit Item #1: Pedigree Chart

- Use for:**
- Depicting multiple generations of one family
 - Summarizing a lineage
 - Note: only shows *direct* ancestors, not *collateral* lines (siblings, aunts, uncles)

Use for:

- Summarizing one family unit
- Recording information about collateral ancestors (siblings)
- Note: provides more space for details

Toolkit Item #2: Family Group Sheet

Genealogical Recording Conventions: Names

- Write surnames in all CAPITAL LETTERS
- Record a woman with her maiden name
- When the maiden name is unknown use:
 - [--?--] can be used
 - MNU
 - Just the given name

Genealogical Recording Conventions: Dates


- Record dates as DD-MMM-YYYY
(e.g. 23 MAR 1823)
- Note: Some journals use the date written out in letter form – March 23, 1823
- DON'T:
 - Use slash marks: 3/12/1823
 - Use a two-digit year: 3/12/23

Genealogical Recording Conventions: Places

- Note smallest to largest geographic division (e.g. Orleans, Orange County, Indiana)
- For outside the U.S.:
townland/parish, county, country
- Be sure to identify counties
- Use a consistent style

Step 2: Decide What You Want to Learn

- Examine the information you have
- What is missing?
- What individuals or families intrigue you the most?
- Create a list of questions or objectives to research

 - Events
 - Relationships
- For example:
 - Who are the parents?
 - What is the date or place of birth?
 - What is the date or place of marriage?
 - What is the date or place of death?
 - What is the spouse's name, or maiden name?
 - Who are the siblings?



Start slowly. Don't rush to answer all your questions at once.

Don't skip generations in planning your research; it only leads to misattributed people.

Step 1: Creating Good Research Questions

- Make the question specific, answerable, realistic, timely
- Include name, place and date in the question
- Focus on genealogical questions, e.g.:
 - Identity
 - Kinship
 - Events
- Focus on a person

Step 2: What Do You Already Know?

- About Subject?
 - Identify the *Where* and the *When* for your subject
 - Helpful to list vital events – with *place*
 - Name of spouse(s)
 - Names and DOB(s) for children
- About the Question?
 - Not just what you know, but HOW you know it
 - Focus on what is relevant to the Research Question

- Which records are most likely to have the answer?
- Where are those records? Which repositories?



Step 3: Identify and Locate Your Sources

- Educate yourself – what types of records will supply the information you need?
- Make a list of records that will aid in your specific research
- Find resources in repositories and online
- Map out your plan of action
- Don't forget the "Family Archives!"

 - Does the record bring up new questions?
 - How accurate is the record?
 - How accurate is the source?
- Record the information you have
- Record the sources you use


Analyze

- Evaluate the **Source**
 - Original: first recorded form
 - Derivative: from something already written or spoken
 - Authored: compiled
- Evaluate the **Information**
 - Primary: first-hand (participant)
 - Secondary: secondhand (non-participant)
- Evaluate the **Evidence**
 - Direct
 - Indirect
 - Negative

Principles of Analysis

- Are you looking at an original or derivative source?
- When was the record created, i.e. how soon after the event it is capturing?
- Who created the record? A participant? Someone else?
- Who provided the information?
- Which information is primary (firsthand knowledge) and which is secondary (secondhand knowledge)?
- What information do I need to capture for a citation?

Genealogical Proof Standard


- Reasonably exhaustive research
- Complete, accurate citations to the source or sources of each information item
- Tests—through processes of analysis and correlation—of all sources, information items, and evidence
- Resolution of conflicts among evidence items
- A soundly reasoned, coherently written conclusion.

Why Bother With A Proof Standard?

- Guides your evaluation of evidence
- Provides a framework for putting together a credible argument for a genealogical fact, e.g. who are the parents of Jacob Homer?
- Helps you feel secure with your conclusions, especially when your only evidence is indirect.

- Didn't have to talk to anyone in the house
- Could talk to a neighbor if no one home
- What we view are copies of originals
- Families were not asked to spell their name

Knowing the Family (U.S. Census)

- 1790–1840: lists only the name of the head of the household
- 1850–1870: lists everyone in household, but not how they are related

Generally, can assume people in same household are family (assumed or inferred relationship)

- 1880–1950: relationships listed

HISTORY OF MERCER COUNTY.

1878. They reared eight children: Samuel, Abraham K., John, Maria, Linna, Marvin, Madison and Ann, all residents of the county except Samuel, who lives in Michigan. Abraham K. was reared in his native township, and married June 10, 1836, Mrs. Sarah Smith, nee Lawton, a native of Yorkshire, England, who has borne him five children: Silas, Catharine (wife of Oscar Brockway), Peter, Daniel and Anna S., all living. Politically Mr. Harnis is a staunch Democrat, and one of the oldest native residents of the township.

JACOB HASENPLUG, farmer, post-office Greenville, was born in Centre County, Penn., October 24, 1830. His grandfather, Henry Hasenplug, emigrated from Germany to America during the Revolution, and after the war married a Miss Siebold, of Union County, Penn. His father, Jacob Hasenplug, was born in Union County July 16, 1790, there grew up and married Annie Lechty, a native of the same county. They afterward removed to Centre County, where Jacob operated a tannery and brewery. In the fall of 1834 they removed to West Salem Township, Mercer County, and reared six children: George E., deceased; Elizabeth, wife of Jonathan Showers; Jacob; Maria, widow of William Dillon; John H. and Daniel. They settled in the forests of West Salem, in a hewed log house which Mr. Hasenplug erected after coming. The mother died in 1871, and her venerable husband, at the ripe old age of ninety-three years, resided on the old homestead, peacefully awaiting the call to join her in that home beyond the grave, until his death August 7, 1888. Both died in the faith of the Evangelical Association, of which church they were members many years. Politically he was a Republican. Our subject has resided in West Salem since the fall of 1834. He learned the shoemaker's trade, which he followed at Mayville for twenty years, but since the spring of 1882 he has been engaged in farming. In the fall of 1862 he was drafted, and enlisted in Company D, One Hundred and Sixty-ninth Regiment, Pennsylvania Militia, and served nine months. Mr. Hasenplug was married in April, 1855, to Mary Ann, daughter of Jeffrey and Ann (Merford) Bentley, of West Salem Township. She was a native of Mercer County, and reared nine children: Elizabeth, wife of Charles Busell; Emma, wife of Squire Jewell; Elmer E., Armina, Ida, Charles, Ella, Sadie and Lorinda, all of whom are living. Mrs. Hasenplug died in the Baptist faith May 7, 1875. Our subject is a Republican, and one of the well known citizens of the township.

THE HOMMER FAMILY.—Jacob Hommer, a native of Germany, and a Revolutionary soldier, was one of the early settlers of West Salem Township. He grew up in Maryland, and was twice married. His first wife was Mary Siler, who bore him three sons and four daughters: John, Joseph, Jacob, Polly, Lena, Susan and Elizabeth. The mother died in Maryland, and he married Mrs. Hannah (Booth) Schaffer, and with two sons, John and Jacob, and his four daughters, by his first marriage, immigrated to Mercer County in 1809 (Joseph remaining in Maryland), where he purchased and settled on a tract of land partly lying within the present limits of Greenville. Two daughters, Hannah and Rachel, were born of his second marriage. His cabin stood on the west side, where Samuel West now lives. The parents both spent the balance of their lives on this farm, upon which they were interred. John, the eldest son, married Catharine Harsh, in Maryland, and after coming to Mercer located at the Big Bend, in Delaware Township, where his father purchased him 100 acres. He died there, and his sons still live on the old homestead.

Joseph, the second son, was born in Maryland May 13, 1791, there learned the shoemaker's trade, and came to West Salem Township about two years after the rest of the family. He married Magdalena Everhart, who was born


