Brief History

- Native Nations of New England: <https://www.americanancestors.org/education/learning-resources/read/native-nations-of-new-england>
- Plymouth Colony
 - Established 1620
 - Encompasses SE Mass., Cape & Islands
 - Core group were Separatists who had first fled to Leiden, Holland
 - Small in population and grew slowly
 - Friendly relations with Mass. Bay
 - Emigration to Berkshire Co., MA; Dutchess Co., NY; Cape May, NJ; coastal Maine
- Massachusetts Bay Colony
 - 1620s scattered settlements on Cape Ann
 - 1628 Endicott group to Salem
 - 1630 Winthrop Fleet to Boston
 - Established and led by Puritans
 - By far the most populous and influential colony in New England
 - Dissidents soon founded NH, Providence, Conn, and New Haven Colonies
- History of Colonization
 - Plymouth Colony and Massachusetts Bay Colony merge in 1691
 - Always the largest and most influential New England colony
 - Maine part of Mass. until 1820
 - Major location point for migration north, west, and south

Records

- Early Massachusetts Records
 - Vital and church records: birth, baptism, marriage, death, burial, divorce, gravestone
 - Land records: grants, deeds, mortgages, gifts
 - Probate records: will, inventory, guardianship
 - Civil records: lawsuits, individual vs individual
 - Criminal records: prosecution by authorities
 - Military records: Colony, town militia
- Colonial Government
 - Colony – Records of General Court, laws, appeals, border disputes, diplomacy, war
 - County or Jurisdictional Courts – Criminal and Civil actions
 - Towns – Selectmen, elected officers (Town Clerk), vital records, town grants of land
- Access to 17th century original records
 - Originals not often available to the public
 - Microfilm images
 - Digital images online – replacing microfilm
 - ✓ AmericanAncestors.org
 - ✓ FamilySearch.org
 - ✓ Ancestry.com

Vital Records

- Mass. has the most complete set in the nation
- Kept by towns beginning in 1620s
- Generally are well-kept, but not always complete
- VRs up to 1850 published for over 200 towns, the majority in eastern Massachusetts
- For other towns, use the Corbin Collection, Rollin H. Cooke Collection, Holbrook microfiche, or manuscripts (all available at NEHGS)
- Vital Records to 1850
 - Systematic History Fund series = “Tan Books”
 - Births, marriages, deaths arranged alphabetically
 - May include VRs from church, cemetery, Bible, or private records
 - Most online at AmericanAncestors.org
- Vital Records Pitfalls
 - Not all VRs were recorded
 - Events may have occurred in one town, but were recorded in another
 - Don’t assume that if you can’t find a VR, that the event happened in a different town
 - Event may not have been recorded at all

Church Records

- Baptisms, deaths, and burials
- Admissions of church members
- Disciplinary records
- Letters of dismissal

Town Records

- Comprised of many different types of records: town meeting, selectmen's records, tax rolls, proprietors' records, cattle marks, warnings out, pauper records, etc.
- Where are they located?
- Often not indexed and occasionally in print
- Local town & city clerk's offices, or historical societies have originals
- Some have been imaged on microfilm or digitally from the FHL Library

Freeman Lists

- Lists establish date of residence
- Free of indenture
- Church membership required prior to freemanship in Massachusetts Bay
- Freemen were allowed to vote for colony officers
- Abstracted in Great Migration series
- Massachusetts Bay
 - Colonial Freeman Lists
 - Massachusetts Bay Colony
 - Records started May 19, 1631
- Plymouth Colony
 - Part of Colony Court proceedings
 - Surviving lists are from: 1633, 1637, 1639, 1658, 1670, 1684

Proprietors' Records

- Proprietors were responsible for the improvement of the land and were required to enlist settlers and newcomers, assigning lots, building highways, and subdividing land/meadow/forest
- Early record of community
- Can include land grants and early deeds
- Where to locate Proprietor Records
 - Town Halls: Town clerk, tax office or assessor
 - County Registry of Deeds
 - Libraries and local historical Societies
 - FamilySearch.org microfilm and online
 - Published transcriptions of Proprietor records

Massachusetts Land Deeds

- Organized by county
- Berkshire, Bristol, Essex, Middlesex, and Worcester have multiple deeds registries
- NEHGS has microfilm for some counties to 1800s or later
- For married male grantors, wife usually signs as well
- Usually lists occupations
- Barnstable County deeds burned in 1827 (only partially reconstructed)
- Be aware of changing county boundaries

Massachusetts Probate Records

- Proof of death (between date of will and probate)
- Family relationships, widow, legatees
- Personal bequests
- Financial status, land ownership
- Be sure to confirm the accuracy and completeness of published records

 - Hampshire 1660-1889
 - Middlesex 1648-1871
 - Plymouth 1686-1881

 - Other counties available for later year

Court Records

- Criminal activity by or against an ancestor
- Infractions against town or colony rules
- Civil actions by or against ancestor
- Property, real, animal
- Relations with neighbors
- Social and financial status
- Few images available; FHL Microfilm
- Criminal and Civil Abstracts
- Divorce Records
 - 1639-1692: County Courts, General Court, Court of Assistants
 - 1692-1786: Governor & Council

Massachusetts Archives Collection: 1629-1799

- 328 volumes about early Massachusetts history (also called the Felt Collection)
- Access the collection at the Massachusetts Archive or browse on FamilySearch.org

Military Records

- Few details for 17th century muster rolls
- Mostly colony records, original at Mass. State Archives
- Town records – local militia
- Military history chapters appear in many published town histories.
- Mostly Colony records, originals at State Archives

Earliest Passenger Lists to Massachusetts

- *Mayflower* from Bradford's account 30 years later
- *Fortune* (1621), *Anne* and *Little James* (1623) from land records.
- Surviving London Port book 1632-1635
- Post-1636 are very limited
- Rely on published sources (*see bibliography*)

Strategies

- Common Challenges
 - Distinguishing between people of the same name in the same community
 - Determining parentage when multiple marriages are involved
 - Finding women's maiden names
 - Origins
- General Considerations and Suggestions
 - You may not find one “smoking-gun” record; you may need to rely on a number of records to build a case
 - Some records may be less reliable than others
 - May have several working theories
 - Know when a town was established; parent/daughter towns may affect record keeping
 - Create a complete timeline with probate, land records, military, or any possible record
 - While not culturally consistent, some families used naming patterns
 - Surnames as first names or less common first names can be clues of earlier kinships
 - Do not assume a woman's name at marriage is her maiden name
- Remember:
 - Terms of kinship may have different meanings in 17th century Massachusetts:
 - Nephew and nieces may be referred to as “cousins”
 - “Brother” or “sister” can be indications of brothers and sisters within a faith
 - “Father” and “Mother” could refer to in-laws
 - Use of “Jr” and “Sr” don't necessarily mean kinship
- Summary
 - Don't rely on just one record set
 - Don't reinvent the wheel! Look at published sources in combination with originals
 - Keep up with scholarly publications
 - More and more records are being indexed and digitized everyday!
