Michael² Metcalf, the eldest surviving son of Michael¹ and Sarah (Elwyn) Metcalf, was named after his father and a brother who died in infancy. Michael² emigrated with the family when he was 16 years old. After spending his childhood in England, this elder son would become part of the generation that firmly established the community of Dedham. He was admitted as a freeman at 22 years of age on May 13, 1642, only five years after his father joined the town.¹¹⁴

Marriage to Mary Fairbanks

Two years later, he married on April 2, 1644, Mary Fairbanks, who was born at Sowerby, Halifax Parish, Yorkshire, England, on February 3, 1622, to Jonathan Fairbanks and Grace (Smith) Fairbanks.¹¹⁵ Lorenzo Fairbanks suggested that Jonathan Fairbanks had immigrated to Boston by 1633; however, genealogist Robert Charles Anderson does not believe he had arrived in New England by then.¹¹⁶ In any case, Jonathan Fairbanks settled in Dedham in 1636, a year before the Metcalfs arrived. It appears that Fairbanks began to build his house in 1637, because some house timbers date from that time. The Jonathan Fairbanks house stands today and is considered "the oldest timber-frame building in New England."¹¹⁷

Life in Dedham

Church life was extremely important to the early inhabitants of Massachusetts. The first church in Dedham was established by eight men on November 8, 1638, as an independent entity with no religious affiliation. It was composed of two parts—the parish and the church. Apparently the first several years of the church saw much dissension, prompting several families to leave the community. Robert Charles Anderson points out, "As a result of all this movement, the immigrants of 1637 and 1638 soon attained a dominant position in civil as well as ecclesiastical affairs."¹¹⁸ Town tax revenues supported the church, and eligible males were allowed to vote on parish matters. To belong to the church, one had to apply and be accepted.¹¹⁹ Being accepted in

Elyria, is inscribed "Anna M. Stevens Rich (1787–1866)."¹²⁰ All but one of her children were living nearby in Elyria, as were fifteen grandchildren. The one known photograph of her and her many letters to siblings and children indicate she was a very spiritual woman of great determination and unflinching interest in and support for her children. She had twice been widowed with small children but had seen to their educations and proper upbringing. Each of her seven children had spent time teaching school.

Children of Charles and Anna Mayo (Stevens) Rich, all born in Warwick, Massachusetts:¹²²


1. CHARLES WILDER RICH, possibly born as Wilder Stevens Rich April 2, 1808; died in Elyria, Ohio, January 28, 1899. Married Albina S. Kittredge, March 11, 1847, in Milo, Maine. They had six children.
2. ALMEDA RICH, born October 5, 1809; died in Brownville, Maine, February 11, 1899. She married first James Madison Searles of Boston on May 19, 1834. They had three children. She married second Gilman Ryder of Dunbarton, New Hampshire, on September 8, 1852.
3. ANNA ELIZABETH RICH, born August 27, 1811; died in Elyria, January 23, 1897. She taught school with her sister Almada in Boston, then on her own in Bangor, Maine. She was principal of Westfield Academy, Westfield, New York, and then was in charge of a ladies' seminary in Racine, Wisconsin. Married Elijah DeWitt, M.D., in Elyria; no children. Author of *The Joys and Sorrows of Home: An Autobiography* (about her mother).

Children of Isaac and Anna Mayo (Stevens) (Rich) Metcalf, all born in Royalston:

1. ISAAC STEVENS METCALF, born January 29, 1822. (*See Generation Eight.*)
2. JOSEPH MAYO METCALF, born July 25, 1823; died in Milo, Maine, December 31, 1850, of "slowly increasing paralysis resulting from a fall." Never married. Joseph was a successful merchant in Bangor. According to his nephew Keyes Metcalf, he was ambidextrous and kept the left page of his account book with his left hand and the right with his right hand, with no discernible difference between the pages.
3. LUCY HEYWOOD METCALF, born May 1825; died in Bangor, August 26, 1856. Married May 17, 1848, Samuel Winkley Furber of Bangor. They had three children.
4. ELIAB WIGHT METCALF, born April 18, 1827; died November 24, 1899, in Elyria. Married Eliza Maria Ely on April 6, 1853, in Easthampton, Massachusetts. They had nine children. Eliab was named for his father's first cousin, a prominent printer in Cambridge, Massachusetts. Many if not all of the Metcalf family records were taken over by Eliab upon Isaac's death. Some of his many Metcalf family records were lost when his home in Elyria burned in 1902.¹²³

Compiling a Bibliography

Introduction

A bibliography—also known as a works-cited, reference list—provides your readers with an alphabetized master list in your genealogical research. Follow genealogists and family historians to use this list to undertake additional research.

This *Portable Genealogist* describes different types of bibliographies you can use to compile and organize your bibliography, and provides examples of how to cite different types of sources.

Basic Guidelines

1. A bibliography should appear in your book's end matter (at the back of the book) and, typically, directly before the index. Bibliographies may be placed directly after each article or chapter.
2. The bibliography provides the full citation for each source. When shortened citations are used in the reference list, the full citation should appear at the beginning of the list.
3. A bibliography does not take the place of reference notes. Reference notes point readers to the exact source of information.
4. In a bibliography, the focus is on the entirety of the source (e.g., letters, diaries, etc.).

Types of Bibliographies


Just as there are different ways of organizing sources, there are different ways of information to include in a bibliography also varies.

Basic bibliography: Lists all of the works cited. This is the most common type of bibliography.

Selected bibliography: Highlights only the major works cited.

Annotated bibliography: Provides notes about each source, including an assessment of the source. This approach is helpful if you are writing a research paper or if you need additional information on analyzing the accessions. Place the annotations in brackets or indent them below the citation.

Bibliographic essay: Allows you to add to or evaluate sources. This approach can work well when sources are not easily listed alphabetically.

Microsoft Word Template for *Register* Style

Main Text

The first paragraph under a heading is set flush left. The Word style is “Normal.” Subsequent paragraphs are indented. The Word style is “Body Text Indent.” This is another paragraph styled with “Body Text Indent.” To learn more about how to write content into *Register* format, see the *NEHGS Guide to Genealogical Writing*.¹

This file contains all the “styles” you need for creating a basic *Register*-style document. The Word styles are indicated by the name of the style in quotes.

For material extracted from another author’s works, usually something that will be five lines of text or more, you might want to use this “Quotation” style, which indents left and right and puts the extract in a smaller typeface. Don’t use quotation marks; they are only necessary when the extract is a phrase or single sentence embedded in the main text.

Writing a Family Sketch Using Styles

1. FIRSTNAME LASTNAME, usually in small caps, in “Main Person” character style. If you select the name and click “Main Person,” the style will be applied. The entire paragraph, though, is “Normal.”

Additional information about the person: “Body Text Indent.”

Children of Main Person and Spouse of Main Person is in the “Kids Intro” style.


 - i. FIRST CHILD. For this list, we are using “Kids” style; the child’s name is in “Child Name” character style. The point size is smaller. You would put relevant vital statistics here.
 - ii. SECOND CHILD. The lower-case Roman numerals are automatically set to align on the right. No need for a period after the identification number in the left margin.
 - iii. THIRD CHILD. Vital statistics here.
