Fundamentals

Fundamental Rules - # 1

All statements must be based only on accurately reported, carefully documented, and exhaustively analyzed records.

– Taken from Robert Charles Anderson's *Elements of Genealogical Analysis*

Rule #1

- Requires you to:
 - Question the validity of the record
 - Question the accuracy of the record
- Need to understand:
 - Who created the record
 - Why was it created
- EVIDENCE

Fundamental Rules - # 2

You must have a sound, explicit, reason for saying that any two individual records refer to the same person.

– Taken from Robert Charles Anderson's *Elements of Genealogical Analysis*

Rule #2

- Requires you to:
 - Draw conclusions
- Deals with the process of combining records
- PROOF

Analytic Tools

- Consists of three tools:
 - Source analysis
 - Record analysis
 - Linkage analysis
- First two deal with examining and evaluating evidence
- Third involves genealogical conclusions

Source Analysis

Source vs. Record

- **Source** – a collection of records
 - Created by a single author (a book of abstracts)
 - Created by a single entity (county probate records)
- **Record** – that item within a source that pertains to a single event

- Are you looking at an original or derivative?



Original Sources

- Digital copies, microfilm, microfiche
considered original for analysis purposes
- Original – From the time period being researched.
Includes:
 - Duplicate original
 - Record (Clerk's) copy
 - Image copy
- BCG Article - QuickLesson 10

Derivative Sources

- Derivative – Written by someone who did not experience the events or time period. Includes:
 - Transcripts
 - Extracts
 - Abstracts

2. When was the source created? **A) *Register* issue was published in 1946; B) Mary Kent (Davey) Babcock abstracted the records BY July 1946 (the date of this issue of the *Register*)**
3. Who created the source? **We need to find the beginning of these abstracts to learn the answer to this question.**
4. What formulas were used in creating the source? **The entries all follow a date; surname of baptized individual; given name of baptized individual; relationship to...; given name of father (assumed, based on wording of relationship); given name of mother (assumed, based on wording of relationship); occasional record identifier**

The REGISTER begins with this issue the publication of the baptisms, marriages and burials as recorded in Christ Church, Salem Street, Boston. As a part of her work as historian of Christ Church the compilation of the vital statistics from 1724 to 1775, the period during which Christ Church was a mission of the Society for the Propagation of the Gospel in Foreign Parts, was begun under the supervision of Mary Kent (Davey) Babcock, wife of the late Rt. Rev. William G. Babcock.

The years 1724 to 1749 were copied from the manuscript records at the church by Mrs. Asa F. Clark and those from 1750 to 1775 were copied from the photostat records at the New England Historic Genealogical Society by Mrs. Babcock's secretary, Mrs. Morton S. Crehore. The manuscript record at the church, made many years ago, showed variations and omissions, therefore the whole period was checked and rechecked with the photostat copies at the Genealogical Society by Mrs. Crehore, who has also completed an index.



- Record pertains to a single event within the source
- Need to evaluate the record asking questions just as with the source:
 - Original
 - Derivative
 - Authored Work
- Need to use a compilation of records

Case Study: Derivative vs. Original

Soulignons que le porc est parmi les premiers animaux de ferme que possèdent les colons de Montréal. L'un d'eux, Augustin Hébert, en a déjà quatre en juin 1654 ²⁰⁸. A l'automne de 1661, il y a « trois Cochons Scavoir deux grands & Un petit » ²⁰⁹ chez Médéric Bourduceau. Durant l'hiver de 1662, « Une truy de Neuf mois environ » ²¹⁰, trouvée chez Lambert Closse, vaudrait quelque vingt livres. Jusqu'à la fin du XVIIe siècle, truie et verrat vaudront de vingt à trente livres pièce. Au siècle suivant, il sera maintes fois question de « cochons nourritureaux » dans le contexte des actes notariés. Il s'agit de bêtes castrées et à l'engrais.

Talon est toujours aussi désireux d'assurer l'expansion économique de la colonie. Le 10 novembre 1670, il voudrait que Colbert fasse adopter des mesures pour « exciter les habitants à nourrir des porcs afin de pouvoir fournir des viandes pour la navigation. J'ay fait charger des larts, de poursuivre l'intendant, que j'avais aportés trop abondamment en quatre





Correlate and Resolve Conflicts

- Two conflicting dates from Ancestry trees. Both trees lack any attached documented. These dates will be discarded.
- She was alive in 1840 per her husband's will and the 1840 census.
- She is missing from the 1850 census. This is negative evidence. She is not there and would have been if alive.
- **Conclusion?** Elizabeth died between 1840 and 1850.
