The Family Bible of John² Wood of Middletown, Rhode Island: Its History and Contents

Editor's Note: Records of births, marriages, and deaths written down in family Bibles are important sources of genealogical information often not available elsewhere. From time to time, the genealogical contents of such family Bibles have been printed in the Register; the usual course in such instances is to devote a relatively short section to the owners and provenance of the Bible in question before moving on to its contents. In this case, however, the emphasis is on that provenance, the history of this Bible's passage from hand to hand, place to place, and circumstance to circumstance.

The Wood Family Bible^[1]

This book, entitled *The Holy Bible in Sculpture*, was printed for Moses Pitt at the Angel in St. Paul's Church Yard in 1683.^[2] The book itself tells a colorful story, even before making its way to the Colonies. The publisher, Moses Pitt of Oxford, developed his business to become one of the largest booksellers in England in the late seventeenth century. He sold Bibles in three different qualities, and customers could pick and choose what they wished to include in their binding. Success in the 1670s led him to embark on a series of interrelated projects, including a large property speculation in Westminster, and taking over the printing office of Oxford University. These projects eventually demanded far more capital than Pitt had available and in 1685 he was forced to sell much of his remaining book stock in two auctions, marking the end of his publishing activities. Some of these auctioned Bibles made their way for resale to the colonies. Pitt's arrest for debt followed in 1689, and he remained in prison until shortly before his death eight years later.^[3]

In this study, the land records of Middletown, Rhode Island were used to support and confirm the Bible records. Using these land ownership records it was possible to document how the family homestead, and hand-in-hand the 1683 family Bible, made their way through seven generations over the course of more than 200 years (followed by another four generations and 100 years off the homestead). The custodians of the family Bible over its history, who for most of that history have also been the owners of the Middletown property, are indicated with consecutively numbered square brackets ([1], [2], etc.), beginning with its first known owner [1] John² Wood.

The Wood family Bible was probably sold at one of these auctions. It was not one of Pitt's highest quality books and had been pieced together from remaining stocks—a New Testament from 1683, a Colophon from 1670, and a Concordance from 1668, bound together in one volume. From an inscription on the inside cover, we know that John Wood of Middletown, Rhode Island was the owner in 1701. For more than two hundred years, this Bible would be held by those descendants who lived on the Wood family farm in Middletown.

The Wood Family in Middletown

The Wood family farm in Middletown, Rhode Island was purchased by John¹ Wood of Portsmouth, Rhode Island (d. by 1655). John Wood first appears in the records of Newport in 1643 when he was accused of trespass. [4] Around 1646, John Wood bought fifty acres "at the Heritage alias Middletown" from Robert Jeffryes; at the same time the town granted him eight adjacent acres for a total of 58 acres. The colonial record immediately following shows "Nuport" granting John Wood additional land in the town, bounded by "Weedens land, the highway [sic] and the Common." [5] John Wood was made a freeman of the town of Portsmouth on 10 July 1648. [6] The land in Middletown is located at what is today designated east of Mitchell's Lane and south of Fayal Road. John Wood left no will; his estate was disposed of by the town council of Portsmouth on 7 May 1655, leaving to his son John² Wood "that land that is in his present possession" and to his son Thomas² Wood his land in Newport. [7] For more than two and a half centuries the land in Middletown would continue to be inhabited by John² Wood and his descendants.

[1] John² Wood (abt. 1620-1704)

On the inside cover of the family Bible, written in painfully small script, are the words *John Wood His Book 1701*.^[8] This cover page would be used by several generations to write their names. John² Wood of Middletown, Rhode

Island, son of John¹ Wood of Portsmouth, died 1704 in Middletown, age 84;^[9] he was included on the list of Newport freemen in 1655.^[10]

The Middletown property passed to John's son William³ Wood probably because his two eldest sons were already living across the sound in Little Compton, John³ Wood having received 11 acres from his father-in-law in 1691 and Thomas³ Wood having received 100 acres in Little Compton from his father in 1695.^[11]

[2] William³ Wood (abt. 1675–1753)

William³ Wood, son of John² Wood, was born about 1675.^[12] William was a Quaker and a freeman of Newport; he married first Amy Clarke, daughter of Latham Clarke, on 13 May 1709.^[13] Amy died in Portsmouth, 7 October 1726.^[14] Of this union were born three children, Mary,^[15] John, and Amy.^[16] William married second widow Elizabeth (Tripp) Mitchell 18 April 1734.^[17]

The names *Mary*, *John*, and *Amy* appear on the inside cover of the Bible, apparently all written in the same hand; they most likely refer to William's three children. William's death on 5 June 1753 was recorded in the Bible: *William Wood Deceacd the fifth of the Fourth Month in the Year One Thousand Seven hundred fifty Three.*

The exact date of William's acquisition of the Middletown property is unknown, but it was clearly in his possession by 1744 when he conveyed it to his son John⁴ Wood.^[18]

[3] John⁴ Wood (abt. 1716–1798)

John⁴ Wood, son of William³ and Amy (Clarke) Wood, was born about 1716.^[19] In December 1744, he was called "of Middletown" when he married Mary Shaw, daughter of Anthony Shaw of Little Compton; the ceremony was performed at the home of her father by the local Justice, Rev. Richard Billings of the "Prispeteran [*sic*] Church."^[20] The couple had three children, two of whom survived childhood.^[21]

John Wood left the land, now totaling 95 acres, to his two daughters Sarah⁵ (Wood) Manchester and Elizabeth⁵ (Wood) Freeborn, who agreed in 1798 to split the land into two parcels; Sarah received 46 acres including the *dwelling house*.^[22]

[4] Sarah⁵ (Wood) Manchester (1753-after 1828)

Sarah Wood, daughter of John Wood and Mary Shaw, was born the twenty-second day of the first month in 1753, which per the Quaker calendar would be 22 March 1753. Sarah's birth is also recorded by Arnold, albeit from a 1795 deposition by Peleg Wood who reported the birth as "January." No other record has been found to address this discrepancy.

Sarah married John Manchester, the son of Isaac Manchester, at Middletown on 8 March 1787;^[24] he died between 1790 and 1800.^[25] The couple are known to have borne two children, Mary in 1788 and Hannah in 1790.^[26] Sarah died after 15 February 1828, when as "Sarah Manchester widow of John Manchester of Middletown deceased" she, along with Mary Anthony (and her husband Philip Anthony) and Hannah Coggeshall (widow of David Coggeshall) sold

10 acres in Middletown to Giles Manchester she entered into a land contract, calling herself "widow of John Manchester of Middletown." [27]

The Middletown property eventually passed to Sarah's two daughters, Mary (Manchester) Anthony and Hannah (Manchester) Coggeshall, who on 13 March 1834 entered into an Agreement to Partition, with Hannah receiving the southerly 46-acre parcel. [28]

[5] Hannah (Manchester) Coggeshall (1790–1864)

Hannah Manchester was born 2 April 1790, daughter of Sarah Wood and John Manchester. She married David Coggeshall in Middletown on 30 November 1815, the ceremony performed by Justice Joshua Coggeshall. [29] Hannah died in Middletown 9 March 1864. [30]

On 20 December 1850 the Wood farm got a new name, when widow Hannah (Manchester) Coggeshall transferred part of the farm and the dwelling house to her son-in-law, James M. Smith, husband of her daughter Sarah Ann (Coggeshall) Smith.^[31]

[6] Sarah Ann (Coggeshall) Smith (1815–1876)

As calculated from her age at death, Sarah was born 4 December 1815, less than a week after her parents, Hannah Manchester and David Coggeshall, were wed. Sarah married James M. Smith at Newport on 9 March 1834.^[32]

Around 1850 the original Wood family home was torn down and a new home built by J. M. Smith.^[33] After this time the property was referred to as the Deacon Smith Farm; he was still the owner in 1870.^[34] Sarah lived on the family farm until her death on 24 June 1876, age 60 years, 6 months, and 20 days.^[35] Though no apparent record of Sarah survives *within* the Bible, it was clearly in her possession; the name *Sarah Ann Coggeshall* is cut into the leather of the cover.

After Sarah A. Smith's death, the land passed to her husband, and upon his death their five children. [36] James M. Smith died in 1889. [37] It was likely at this time that the family Bible was given to Sarah's eldest son, David C. Smith, who in 1870 had been living on the family farm with his wife and first child. [38]

[7] David Coggeshall Smith (1837/8–1925)

David was born in 1837 or 1838, the son of Sarah Ann Coggeshall and James M. Smith.^[39] David married Mercy B. Caswell, daughter of Robert of Newport, on 1 November 1864; they were married by the Methodist minister Josiah Higgins in Caswell, Massachusetts.^[40]

David was the last caretaker of the Bible to have lived on the Wood/Smith farm; as noted above, he was recorded there in 1870 together with his wife, daughter, parents, and sister Annie. He later moved to the farm of his daughter Ella F. (Smith) Molden on Third Beach Road in Middletown. Land records tell us that this 8-acre parcel was left by Mercy B. Smith to her only two heirs, Charles W. Smith and Ella F. Molden. [41] She had purchased this land on her own accord, for \$650, in 1874. [42]

In 1891 most of the southern parcel was partitioned among the heirs, with 22-plus acres "being the northerly part of the homestead farm of Sarah A. Smith" transferred to David C. Smith, William Smith, and Harriet (Smith) Ward, and 17 acres "being the southerly part of the homestead farm of Sarah A. Smith" to Frederick A. Smith and his sister Annie Elizabeth (Smith) Ward. [43] In April 1892, Annie E. Ward sold 6.5 acres and her undivided half interest in the 17-acre southerly parcel to her brother Frederick. [44] The following month, the remaining siblings transferred their ownership of the 22-plus acre parcel to their sister, Annie E. Ward, for "\$10 and other valuable considerations." [45]

After the turn of the century David C. Smith moved to his daughter's farm on Third Beach Road. [46] The family Bible was passed to his son, Charles Wesley Smith, who was living in Newport in 1900. [47] Frederick and his family were still living on the Wood/Smith farm in 1907, but for the first time since 1701 the Bible was not held by someone residing on the family farm. [48] David died in Middletown 14 March 1925. [49]

[8] Charles Wesley Smith (1872–1942)

Charles W. Smith was born in Middletown 12 March 1872, the son of David Coggeshall Smith and Mercy B. Caswell. [50] He married Agnes (Bennett) Reid there in 1892. [51] Charles died in Newport 16 August 1942. [52] Charles lived in Newport and worked as a gardener at a private estate; his home on Roseneath Avenue was just 1,300 feet from Narragansett Bay.

In 1911, Charles's siblings Frederick A. Smith and Annie E. Ward together sold the two parcels of land they owned, encompassing all 46 acres of the southern half of the original Wood homestead, to a neighboring land owner, William J. Peckham. [53] William J. Peckham moved to the 1850 Smith home and was living there in 1921. [54] In 1939 he sold the James M. Smith homestead, plus three other parcels he owned (the four lots totaling 66.5 acres) to George Leonard. [55] Today the area includes small to medium-size farms defined by 20-acre parcels of open fields and pasture. [56] The 1850 home of James M.

Smith still stands, southwest of the Wood Burying Ground, and retains 19 acres of the original John¹ Wood property.^[57]

The Great New England Hurricane of 1938 and the Bible's Subsequent History

In September of 1938, a storm that would come to be known as the Great New England Hurricane made landfall in Long Island as a Category 3 storm. Except for Charlie Pierce, a junior forecaster in the U.S. Weather Bureau who predicted the storm but was overruled by the chief forecaster, the general public never saw it coming—certainly not Charles W. Smith, who was living near the Bay.^[58]

The storm surge followed the Rhode Island coastline and into the bay; Providence was submerged under a storm tide of nearly 20 feet. [59] Rhode Island recorded sustained winds of 100 mph with a gust to 125 mph. The lowest pressure at the time of landfall occurred on the south side of Long Island where a reading of 27.94 inches was recorded; 28.00 inches was recorded in Middletown. Entire beach communities on the coast of Rhode Island were wiped out by the hurricane; the storm at Newport sustained 13 feet of surge. The only structures lying directly on the coast that endured the storm were the immense stone mansions in Newport. Across New England the hurricane killed more than 600 people, damaged tens of thousands of homes, and completely destroyed some 19,000 buildings. [60]

Although the Smith family did not lose their home, the 1683 Bible was one of the items damaged by the swiftly rising water. Decades later its spine was still curled upon itself due to water damage, and the rear cover was completely lost. Despite its badly damaged condition, the Bible continued to be a treasured heirloom, passing from Charles W. Smith to his son, [9] Everett Williston Smith (1893–1983), to his daughter, [10] Janet Williston (Smith) Marvelle (1923–2019), and then to her son [11] Robert Marvelle (1953–2021).

Robert Marvelle was the long-time caretaker of Marble House in Newport and keenly aware of each generation's responsibility to preserve the past. Through his generosity, in 2019 the Bible was gifted to this author, an agnatic descendant of the book's original owner, John² Wood of Middletown. During the pandemic, over the course of several months, the Bible was fully deconstructed and restored using period bookbinding techniques. It remains today a treasured family heirloom. [61]

The Family Data

In addition to the names written on and inside the Bible's cover, including those of his children, [3] John⁴ Wood and his family added a full page of notations in the Bible. All of the dates are written in the Quaker style. Vital records are recorded for three generations, in at least two different hands, some of the records incomplete due to tears and missing pieces.
